Police and the Community

No Police were in attendance

Weardale Resilience Group-Rev C McClelland and S Langan

Cllr Craig welcomed the speakers to the meeting. The group was formed after storm Arwen happened so that if there was an emergency in the future the response would be quicker. The meetings that had been held all came to the same conclusion that the Village Halls should be used as information hubs and a place where hot drinks could be provided. The CCU will work through the Resilience Plan and each village should have their own plan as local knowledge is necessary. It was felt that the Parish Council should take the lead on the Resilience Plans as these need to be kept up to date so could be checked every year at the AGM. **Resolved:** Clerk to contact L Dobson from the CCU to attend a meeting at the Dales Centre. A representative from each Village Hall to be asked to the meeting.

Matters Arising

1. **STEPPING STONES, STANHOPE** – The stepping stones have been inspected and at this moment in time they do not need the small stones removing. The Ford will be monitored and any concerns then we can report them again.
2. **HOOD STREET, ST JOHNS CHAPEL** – The Police are aware of the parking issues on the main road and in terms of enforcement it is not something that they can do due to the layout of the road and understandably residents needing to park their due to there being no alternative parking in the village. DCC have been approached regarding the possibility of getting some extra traffic measures put in place by the junction for School Close which was rejected. A vehicle causing an immediate obstruction should be reported to the police via 101 and an officer can be sent to assess the vehicle and appropriate action taken at the time.
3. **ALLOTMENT TENANCY AGREEMENT** - A notice has been put on the allotment sites with reference to the wording of 10.2 where “ poultry” has been changed to hens and cockerels are allowed in addition to this number as agreed at the February meeting 2022.

Correspondence Received

1. Cllr Brewin reported a footpath from Western Hill to Crower Lea is very slippery. D Hunt will get the Community Highways Worker to clean it. D Hunt mentioned that the steps have been cleaned off and the track belongs to the County Durham Housing Group. He is going to see if anything can be done with it.
2. DCC and CDALC emails have been sent to the councillors.
3. An email has been received from M Murden regarding drainage works on footpath 39, Wearhead. The existing drain will be replaced with a bigger diameter pipe and surface with filter stone along the entire length of the path from the corner to the burn. This will hopefully give a bigger flow and keep the path surface drier.
4. The County Council of Durham are proposing a 30mph speed limit restriction on the A689 at Daddry Shield from 50metres east of Bridge End Cottage in a south westerly direction for a distance of 575 metres to appoint 130 metres west of Number 15 Front Street, Daddry Shield. The email was sent to all of the councillors.
5. We have been sent details of draft proposals of the Union of Parishes of St John’s Chapel and Westgate and the closure of the Church of St Andrew Westgate. The new parish shall be named The Parish of St John’s Chapel and Westgate. Any views or requests for a meeting with the Committee’s representatives should be forwarded to the Governance Support Manager not later than 2nd May 2022.
6. An email has been received from the Green Lane Association regarding Countryside Access. The email was sent to all councillors.

Platinum Jubilee

New Matters for Discussion

1. Cllr Mrs Sutcliff would like to report that the bottom railing is loose on Ponders Lane Bridge which is opposite the school at St Johns Chapel. **Resolved:** Clerk to report to DCC
2. Cllr Miss Carrick would like to report the fence opposite the Grey Bull has not been repaired yet. **Resolved:** Clerk to report again to DCC
3. There are parking problems on the Market Place, Stanhope as people are parking too far across and the buses cannot get through. Some cars are being parked outside where the funeral directors are which totally blocks the access for the buses to the bus stop. You cannot see the parking bays anymore as the paint is very faint. **Resolved:** Clerk to write to DCC
4. There is a pot hole on the highway opposite the CO-OP near to the Lime Tree Gallery that needs repairing. **Resolved:** Clerk to report to DCC
5. A resident mentioned that there is free transport to New College in Durham but to travel to Durham High School 6th Form you have to pay. A councillor mentioned that Durham High School is a private school. **Resolved:** Cllr Miss Carrick will contact the resident.
6. Cllr Mrs Sutcliff had a resident mention to her that the stepping stones in Westgate had been fenced off. Cllr Craig reported that there are no stepping stones at the Ford at Britton.

Clerks Business

1. Following the collection of the allotment rents some points were brought up by some of the tenants. Plot 5 at Bondisle has not been worked at all. He is unwell but we need to find a solution. It was suggested that the next person on the waiting list share the plot but the tenant did not agree to this. Plot 4 at Crosshill is not worked and complaints have been received about it, the greenhouse is falling to bits along with the fencing. Rats have killed some hens on plot 3 at Willard Grove. The councillors seemed to think it would be stoat that got in and killed the hens. Cllr Lawrie mentioned that an inspection should be done at Willard Grove. A request has been received to see if it would possible for some water at Ireshopeburn allotments. The councillors mentioned that when people take an allotment on at Ireshopeburn they know that there is no water at that site.
2. A Get-Well card has been sent to Fiona Graham wishing her a speedy recovery.
